

Welcome to VKC's agility trial. Thank you for coming to our trial; we hope you have a great time.

Thank you for your entry. The trial has now closed. This is all the information you need to know to get here and have fun with your dogs. Please check your confirmation carefully. Please adhere to the following guidelines:

Crate setup will be allowed once the rings have been setup the day before the trial.

Please pick up after your dogs.

Dogs must be on leash at all times when not in the ring or using the warm-up jump - no exceptions!

THE RUNNING ORDERS WILL BE POSTED BEFORE THE TRIAL FOR ALL DAYS AFTER INITIAL MOVE-UPS ARE PROCESSED (which means daily move-ups are not included). Access this information at www.barc4agility.com and click on Events.

JUDGING PROGRAM

First dog on the line at 8 am.

The park is open at 7:00 am. You can set up crates/tents around the ring. Please be aware that this is a public park, it is your choice if you want to leave things up overnight.

This is a small trial, however, we will still split Master/Excellent classes so that we can have workers.

Premier, Novice and Open STD & JWW classes will each have one walk thru.
Master/Excellent JWW and STD will be split as such: walk/run 4-16, walk/run 20-24

T2B will walk/run all
Premier, Novice and Open STD & JWW classes will each have one walk thru.
Master/Excellent JWW and STD will be split as such: walk/run 24-20, walk/run 16-4

A NOTE ABOUT HOW WE ARE RUNNING FAST

When offering all levels of FAST with the combined course structure one course is set up with three different send bonuses - one for each level. Each trial can run this differently, so here's how we're doing it:
Within each height we will run the Master, Excellent, Open and Novice dogs so there aren't as many height changes necessary. I will spread dogs as much as possible, please do not move your dogs in the running order without asking first since this can make a difference in your scoring and the judge has to know what bonus you're going for to qualify. Thank you for your cooperation!

MOVE-UPS

There will be day-to-day move-ups at the show provided the Trial Secretary receives them within 30 minutes after the end of the last class. There will be no move-ups in the morning before the start of the trial.

MEASURING

As of March 1, if a VMO or Agility Field Representative is measuring dogs at a trial, all present and entered dogs without a valid measurement must be measured. Until further notice, Judges of Record who are not VMOs will still not measure dogs. At this time, there will NOT be a VMO at this trial, so no measuring will be done.

DIRECTIONS

Take Exit 39 from I-75 in Adel, GA. Go West on GA 37 towards Moultrie. In approximately 6 miles turn right onto Evergreen Church Rd. In approximately 0.5 mile take a left and follow the road to Reed Bingham State Park. Once passing through the gate, follow the road to the right. The trial will be across from the playground.
