MOVE UPS: Move-up requests for the trial must be made in writing and must be received by the Trial Secretary no later than Monday June 10, 2024 at 6PM Eastern. They may be emailed to Jacqui O'Neil at barc4agility@gmail.com. Move ups for Saturday trial will be permitted on Friday, June 14, 2024 up to 30 minutes following the end of the Friday trial. Move ups for Sunday trial will be permitted on Saturday, June 15, 2024 up to 30 minutes following the end of the Saturday trial.

CONFIRMATION: If you provided a valid, legible, unblocked email address, your entries will be acknowledge via email when received. Final confirmation and judging schedule will also be sent via email— you will NOT receive a confirmation via US Mail. If you do not provide an email address, your confirmation of entry and judging schedule will be mailed to the address provided on your entry form. If you have not received a copy of your confirmation 10 before the show, please contact the Trial Secretary.

ONLINE ENTRIES

This trial is accepting online entries through **LABTESTEDONLINE.COM**. Go to <http://www.labtestedonline.com> to create a user account and add your dogs. Then look for the trial on your My Local Events page or search by state for GA. Click on the "I" information icon to the right of the club's name to create your entry. During the first 48 hours after opening, the initial limit of entries designated as either online or paper will be as follows: 50 runs online, 300 runs paper each day. If either form of entry has not filled at the end of the 48-hour time period, the club reserves the right to decrease or increase either one accordingly.

OPENING DATE: With preferences to Dalmatians **Wednesday, March 6th, 2024 at 8 AM Eastern** sent to the Trial Secretary's address or online service. Only Dalmatian entries will be processed until Wednesday, April 3, 2024 at 6 PM Eastern, after which all other entries will be processed in the order received. All entries received before Wednesday, March 6th, 2024 will be considered invalid entries. Overnight or certified mail must be sent with the "No Signature Required" waiver signed.

CLOSING DATE: **Wednesday, May 22, 2024 at 6 PM Eastern**, or when the numerical limit has been reached, if reached prior to this date, at the Secretary's Office, after which time entries cannot be accepted, cancelled, altered, or substituted except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows. Envelopes/transactions containing entries for more than the ten (10) dog maximum and/or entries received prior to the opening date shall be treated as an invalid entry.

NOTE: In order for Dalmatians to be included in the Dalmatian Club of America's National Catalog, all Dalmatian entries need to be received by **Wednesday, May 15, 2024**.

CANCELLATION OF ENTRIES BEFORE CLOSING: Entries cancelled before closing will not be charged any processing fees. Entry checks will be shredded.

REFUNDS: There shall be no refunds for entries withdrawn after the closing date in the event a dog and/or handler are injured, absent, or dismissed from competition, regardless of the reason for such dismissal.

WAITLIST: A waitlist will be created should the trial entry limits be reached prior to closing. At that time the list will be kept in order received. Should any entries be cancelled before 6 PM Monday, June 10th, they will be replaced with runs from the waitlist. Only entries replaced by waitlisted entries will receive full refunds. If there are no entries willing/able to replace cancelled entries after closing, refunds are not given. Waitlisted entries that do not get in by 6-10-24 at 6 PM Eastern will be refunded.

NOTICE TO EXHIBITORS - ALL EVENTS



The American Kennel Club Rules and Regulations will govern this show and exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List.

- The American Kennel Club will collect: a \$3.00 Event Service Fee for the first entry of a dog and \$3.50 service fee for each additional entry of the same dog in the regular and non-regular recordable single-entry classes, in all AKC licensed and member club events. (There is no recording fee or event service fee for sweepstakes, futurities, brace/team, multi-dog classes or special attractions.). The current 50 cent recording will continue to be collected. The event-giving club shall assume the responsibility of collecting all Event Service Fees for the American Kennel Club.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or Executive Dog Shows, LLC assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. Executive Dog Shows will add a \$30.00 collection fee to the amount of each returned check. We will not re-process checks. The exhibitor will be contacted & required to send a money order for the original amount PLUS the \$30.00 NSF fee. Subsequent returned checks from same person may result in their being put on a CASH ONLY BASIS.
- REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed by the Secretary to said Exhibitor or Agent AFTER THE SHOW.
- Females in season are not permitted to compete in Agility Trials. If a female is withdrawn from competition because she came into season and the Show Secretary is notified no later than one half hour prior to the start of the first class in the trial, the Club is required to refund the entry fee. The Clubs may retain a processing fee and must publish this information in the premium list. Clubs may determine the documentation, if any that is required to confirm the female is in season. This shall be stated in the premium list. Note: No fee is paid to the AKC for females in season who are withdrawn.
- FAX ENTRIES - Fax entries are not accepted.
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly.
- Please Note: Any hotel or motel listed in the premium list is subject to Event Committee Rules. We expect our exhibitors to be responsible guests. A report that an exhibitor at this show has abused hotel or motel property during this week/weekend may result in disciplinary action. Clubs reserve the right to decline future events from the offending party in accordance with the provisions of Chapter 11, Section 15 of the Rules Applying to Dog Shows.
- Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the club nor its Show Secretary will be responsible or obligated to furnish any service for notifying exhibitors or their agent of Breed or Class Judging. Judges need not wait for any dog holding up a class, Owners or agents alone are responsible for the presence of their dogs in the judging rings.
- Only dogs eligible for the shows will be admitted into show area. There is no provision for unentered dogs.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Additionally, clubs should include any specific local health requirements; for example proof of rabies vaccination.
- Waiver of Rights The club reserves the right to remove any animal in distress from a parked vehicle or crate, and all persons attending these dog events hereby waive any claim for damages against the clubs for such removal. PLEASE NOTE: It is expressly understood that exhibitors or spectators alone are responsible for the behavior of their dogs and/or children. Any exhibitor or spectator whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior or whose equipment creates an impediment to the safe flow of traffic may, at the discretion of the Event Committee, be asked to leave the event site. In such cases, no refund of any fees paid will be made. The show-giving clubs, Georgia National Fairgrounds, show secretary, their agents, employees, etc., assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, or any of their dogs or property and further assume no responsibility for injury to children & further expect exhibitors and spectators to keep their children and dogs under strict control.

DOGS ELIGIBLE TO ENTER

These trials are open to all dogs (June 14, & June 15) and Dalmatians only, on June 16, 2024 DCA Specialty in one trial, fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word “dog” is used in these regulations it includes.

MEASURING & HEIGHT CARD INFORMATION

MEASURING: All dogs without a permanent or temporary height card will have to be measured by the **Judge of Record** PRIOR to running. However, if a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present; ALL dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog ticketed by the Judge of Record if the VMO or Rep is not available to measure the dog **before** its first run of the trial or cluster of trials. It is the exhibitor’s responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying score. **Judging will not be held up or interrupted for measuring.** Height cards are not required to be submitted to the trial secretary, however, all exhibitors should carry the original AKC official jump height card with them to each trial in order to present the card upon request. When filling out the entry form, there is a section on the form for exhibitors to designate whether your dog needs to be officially measured. Please check the appropriate box so that the Trial Secretary knows whether to include your dog on the Dogs To Be Measured List. It is no longer required that you submit a copy of your dog’s jump height card with your entry form or show it during day of show check-in

Owners are responsible for entering the proper height divisions. Handlers of dogs in Regular Classes may opt to run in a higher height division, but not in a division lower than their proper height division. Dogs entered in the Preferred Classes **MUST** jump in their measured division and are not allowed to jump higher or lower.

OBSTACLES

Obstacles used will be those as defined in The AKC Regulations for Agility Trials. All contacts are rubberized, bar jumps are 5 feet in width and are polymer plastic design, and spread jumps have rubber cups. Electronic timing will be used. Equipment will be provided by the Atlanta Kennel Club.

COURSE WALK-THRUS AND WARM-UPS

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent. A warm-up area, consisting of a regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

CLASS CHANGES EFFECTIVE JANUARY 1, 2020

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend Multiple Jump Heights Within the Same Trial Day: Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. For example, the same dog may now be entered in Regular FAST and/or T2B to finish up those titles while also entered in Preferred Master STD/JWW to start working towards their PACH at the lower height. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day. Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day. A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend. When calculating entry fees, treat multiple entry forms for the same dog as if only one form had been filled out. In other words, the 1st run entry fee is only paid once per day, per dog, even if that dog's runs have been submitted on multiple entry forms.

Entering For Exhibition Only (FEO): FEO allows exhibitors to work with their dogs in a trial environment. FEO is only allowed in the Time 2 Beat and FAST classes. FEO will be of value to new exhibitors or exhibitors that are having difficulty with a specific obstacle and/or ring environment. Competitors must enter in T2B and/or FAST. Participation in FEO is non-qualifying. FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.

Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed. Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.

The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board). Toys are allowed in the ring. Toys must be non-audible.

Toys may not leave the handler's hand. Toys that roll freely cannot be used. Food/treats are not allowed in the ring. FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.

A judge must monitor the entire run. Judges can stop a run at any time.

Fix and Go On (FNG): FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If a measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.
