Please adhere to the following guidelines:

Crate setup will be allowed after the rings are setup the day before the trial. The park is open at 7:00 am. You can set up crates/tents around the ring. Please be aware that this is a public park, it is your choice if you want to leave things up overnight.

Please pick up after your dogs.

Dogs must be on leash at all times when not in the ring or using the warm-up jump - no exceptions!

#### MOVE-UPS

There will be day-to-day move-ups at the show provided the Trial Secretary receives them within 30 minutes after the end of the last class. There will be no move-ups in the morning before the start of the trial.

#### MEASURING

I will be the measuring official at this trial. If you need a measurement, it must be done BEFORE you run. Come early enough to allow time for this to be done without stressing out your dog before they run.

#### DIRECTIONS

Take Exit 39 from I-75 in Adel, GA. Go West on GA 37 towards Moultrie. In approximately 6 miles turn right onto Evergreen Church Rd. In approximately 0.5 mile take a left and follow the road to Reed Bingham State Park. Once passing through the gate, follow the road to the right. The trial will be across from the playground.
