

Welcome to MADTA's agility trial. Thank you for your entry. The trial has now closed. This is all the information you need to know to get here and have fun with your dogs. Please check your confirmation carefully. If there are any errors contact Jacqui O'Neill, Trial Secretary, immediately at barc4agility@gmail.com. If you need to make corrections, please put "MADTA entry" in your subject line.

Please adhere to the following guidelines:

Please pick up after your dogs.

Dogs must be on leash at all times when not in the ring or using the warm-up jump - no exceptions!

AKC is now allowing maps to be electronically distributed the night before the trial. Watch your emails. Judges are allowed to send them to trial secretaries no sooner than 9 pm; I am not allowed to send them out until after midnight each day of the trial. They will also be posted on my website for each day.

THE RUNNING ORDERS WILL BE POSTED BEFORE THE TRIAL FOR ALL DAYS AFTER INITIAL MOVE-UPS ARE PROCESSED (which means daily move-ups are not included). Access this information at www.barc4agility.com and click on Events.

The site is open at 7:00 am.

CRATING IS ALLOWED IN THE AIR-CONDITIONED BUILDING. The building will be open **Thursday 3:30-5 pm** to allow setup time for exhibitors who wish to crate inside. You must put mats under your crates/chairs to protect the flooring. There is plenty of room for everyone, but if you are taking up too much space, you may be asked to condense your area. If you are crating inside the building, please allow parking closest to the ring for those who are working out of their cars. NO CRATING IS ALLOWED IN THE PARKING AREAS!!

NEW AT MADTA: There is now a camera outside to show the ring on the big screen tv inside. If you are crated close to the tv, please do not stand up in front of it, blocking the view of those behind you – Thank you!

Traveling East on Hwy 40: from SW 80th Avenue travel 1.2 miles and turn left onto NW 68th Avenue. Follow **** above.
