There will be no move-ups in the morning before the start of the trial.

MEASURING - If you need to get your dog measured, please allow ample time. Measuring will be done as time allows by me, Jacqui O'Neill. Don't wait until the last second to get here, please allow ample time to get your measurement done without stressing you and your dog.

DIRECTIONS - From I-75: take exit 358, State Rd 326, go East Approximately 1 mile to traffic light turn left onto 25A (Gainesville RD), go North approximately 2.3 miles. Show Grounds on right with Greater Ocala Dog Club Sign.

From EAST: Hwy. 40 (Silver Springs Blvd) through Ocala to I-75. Go North to Exit 358, SR 326 and follow directions above.
